The CARE Program offers **FREE** energy efficiency upgrades to reduce the monthly energy bills of income-qualifying households in our service territory. You can save up to 25% annually on your energy bills after going through the CARE program.

### DO YOU QUALIFY?

- You are a homeowner or renter with landlord approval
- You live in a house, townhome, condo, apartment or mobile home
- Your household annual gross income must be at or below 80% of the area median income (income verification required, income tables by county on reverse)
- You are serviced by a participating utility company (please call for Energy Outreach Colorado for full list)

### WHAT DO YOU GET?

- **FREE** home energy audit
- **FREE** energy efficiency upgrades to reduce your energy bill and make your home more comfortable

#### UPGRADES MAY INCLUDE

- ▶ Furnace or boiler tune-up and safety check
- ▶ Crawlspace, wall and attic insulation
- ▶ Energy Star refrigerator
- ▶ Air sealing
- ▶ Storm windows
- ▶ Low-flow fixtures
- ▶ LED light bulbs
- ▶ Programmable thermostat
- ▶ Evaporative coolers
- ▶ Energy conservation tips

### HOW CAN I PARTICIPATE?

1. Call your local agency or go online to get a CARE Program application ([www.energyoutreach.org](http://www.energyoutreach.org))
2. Submit a completed CARE application to your local agency or to Energy Outreach Colorado
3. If approved, your local agency will contact you to schedule a free home energy audit
4. Your local agency will then manage the FREE installation of approved energy efficiency equipment in your home
